Important information for the prospective resident

- The *Retirement Villages Act 1999* requires a retirement village scheme operator to:
 - provide a copy of the Village Comparison Document to a prospective resident of the retirement village within seven days of receiving a request
 - include a copy of the Village Comparison Document with any promotional material given to a person, other than through a general distribution (e.g. mail-out)
 - publish the Village Comparison Document on the village's website so that the document, or a link to it appears prominently on each page of the website that contains, or has a link to, marketing material for the village

- All amounts in this document are GST-inclusive, unless stated otherwise where that is permitted by law.

Notice for prospective residents

Before you decide whether to live in a retirement village, you should:

- Seek independent legal advice about the retirement village contract – there are different types of contracts and they can be complex
- Find out the financial commitments involved – in particular, you should understand and consider ingoing costs, ongoing fees and charges (which can increase) and how much it will cost you when you leave the village permanently
- Consider any impacts to any pensions, rate subsidies and rebates you currently receive
- Consider what questions to ask the village manager before signing a contract
- Consider whether retirement village living provides the lifestyle that is right for you. Moving into a retirement village is very different to moving into a new house. It involves buying into a village with communal facilities where usually some of the costs of this lifestyle are deferred until you leave the village. These deferred costs when you leave your unit may be significant.

- Seek further information and advice to help with making a decision that is right for you. Some useful contacts are listed at the end of this document, including:

More information

- If you decide to move into a retirement village, the operator will provide you with a Prospective Costs Document for your selected unit, a residence contract and other legal documents.
- By law, you must have a copy of the Village Comparison Document, the Prospective Costs Document, the village by-laws, your residence contract and all attachments to your residence contract for at least 21 days before you and the operator enter into the residence contract. This is to give you time to read these documents carefully and seek professional advice about your legal and financial interests. You have the right to waive the 21-day period if you get legal advice from a Queensland lawyer about your contract.

The information in this Village Comparison Document is correct as at 21 December 2020 and applies to prospective residents.

Some of the information in this document may not apply to existing residence contracts.

Some or all of the above proposed construction or dealings with the Village Land may constitute 'redevelopment' for the purposes of section 113C of the Retirement Villages Act 1999. An approved redevelopment plan is in effect from 24 June 2020 and prospective residents can obtain a copy of this document on request.

Residents of the Village will be required to acknowledge the following in the residence contract:

- construction activity may be ongoing when the resident moves into the Village; and
- the operator reserves the right at its discretion to:
 - construct the Village in stages;
 - construct further accommodation units, including as part of future stages at the Village;
 - alter the type, size, configuration or design of the units;
 - relocate, reconfigure, renovate, redevelop, extend and/or improve any facilities;
 - subdivide or further subdivide a lot comprising the Village Land;
 - construct additional rooms or areas in the Village to be used for the purpose of office, temporary accommodation or administration; and
 - alter the size of the Village, by incorporating additional or adjoining land into the Village or disposing of, or removing, land forming part of the Village.

Timing

Subject to the scheme operator receiving approval on conditions satisfactory to it, it is anticipated that construction will commence between June 2020 and December 2020 (subject to local government timing to issue all required approvals). This date is an estimate only as at the date of this document and the scheme operator does not guarantee that construction will begin between these dates.

The scheme operator also does not guarantee that the above facilities will be constructed and/or provided. Whether the above facilities are constructed and/or provided will depend on a number of factors including demand for units in the village, availability of finance, market conditions, timing for approvals, weather events, strikes and

During stage 1 of construction (see part 5.2 above regarding redevelopment of the village), the existing pool, BBQ area, gym, auditorium and reflection room will be permanently removed as new community facilities are being constructed. Temporary access to the existing community centre will be provided and temporary visitor car park spaces will be provided.
